- Copy of Federal Tax Return** for the most recent tax year (at the time of filing the case) and the W-2s for the tax return
- Copy of Last Three Month's Pay Stubs**
- 2 Passport Style Photos**
- Copy of Birth Certificate, as proof of family relationship** with English Translation if applicable
- Divorce Paper(s) or Death Certificate(s) from Previous Marriage(s) (if any)** with English Translation if applicable
- Proof of Name Change (if any)** with English translation if applicable

- Proof of Name Change (if any)** in Both Native Language and English Translation.
- Medical Examination:** List of USCIS accepted physicians and the medical form will be provided in the office

Immigration Filing Fees:

- Filing Fees:** Make filing fee check(s) out to the **US Citizenship and Immigration Services** (\$190 + \$325 + \$180 + \$70) **\$ 765** (Work Authorization fee included.) If you are also applying for Travel Document (Advance Parole), it will be **\$170 additional fee** (the total filing fees will be **\$ 935**)
- Filing Fees for children under 14 years of age:** (\$190 + \$225 = **\$415**) If employment authorization card is needed for obtaining a social security number for child then +\$180 = **\$595**

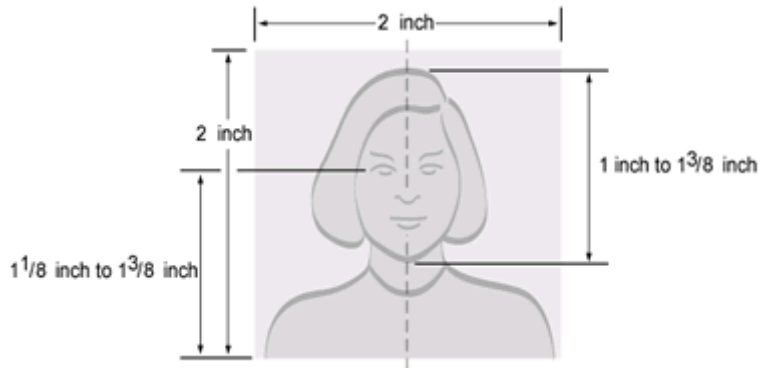
